### 2025 FOURTH QUARTER TARIFF REVIEW DECISION FOR ELECTRICITY AND WATER

For Immediate Release

23-09-2025

#### Background

The Public Utilities Regulatory Commission wishes to inform consumers of electricity and water that, the existing electricity and water tariffs have been reviewed to take effect from October 01, 2025. The adjustments have been carried out in line with the Commission's Quarterly Tariff Review Mechanism. This mechanism tracks and incorporates movements in key factors which are beyond the control of the Utility Service Providers (USPs), namely the exchange rate between the US\$ and the Ghana Cedi, domestic inflation rate, the electricity generation mix, and the cost of fuel, mainly natural gas. These adjustments are undertaken on a quarterly basis to maintain the real value of the tariffs and to keep the utility service providers financially viable to enable them deliver on their services to consumers. Having carefully analysed the existing parameters, the Commission wishes to announce an adjustment of 1.14% across board in the electricity tariffs and 0% increment in water tariffs.

#### 1. Factors under Consideration

The Commission in its analysis, considered the following:

- Ghana Cedi-US Dollar Exchange Rate

The Commission applied a projected Weighted Average Ghana Cedi-US Dollar Exchange Rate of GHS12.3715/US\$1.0000. This projected exchange rate includes under-recovery of GHS0.3980/US\$1.0000 from Third Quarter, 2025 based on an Actual Inter-Bank Average Ghana Cedi-US Dollar Selling Exchange Rate of GHS10.7032/US\$1.0000 for the period June 23, 2025, to September 05, 2025, and an exchange rate projection of GHS11.9735/US\$1.0000 for Fourth Quarter 2025.

- Inflation Rate

The Commission used an annual average inflation rate of 12.43% for the fourth quarter of 2025.

- Price of Natural Gas

The Commission approved a Weighted Average Cost of Gas (WACOG) of USD 7.7134/MMBtu.

- Electricity Generation Mix (Hydro and Thermal)

The projected hydro-thermal generation mix for the quarter under review remained the same at 28.80% for Hydro generation and 71.20% for Thermal generation.

Summary of the applicable indicators are presented in Table-1.

## 2. Electricity Tariff Results

In view of the overall impact of the Hydro-Thermal Generation Mix, Ghana Cedi-US Dollar Exchange Rate, Inflation Rate, and Natural Gas Price and the impending major tariff review under the Multi-Year Tariff Order (MYTO) to be announced before the end of the year, the Commission has taken the decision to adjust Electricity Tariffs by 1.14% across board for all customer categories for the fourth quarter of 2025.
